



Chug Life Inn Doggie Daycare Contract

This Pet Sitting Contract ("Contract") is made effective as of _____, by and between _____ ("Owner"), and Chug Life Inn / Melissa Doyle ("Pet Sitter").

Whereas the Owner wishes to engage the Pet Sitter and the Pet Sitter agrees to undertake the services under the terms and provisions defined in this Contract as well as the Owner's Information Sheet (Exhibit A), Pet Information Sheet (Exhibit B) and the Veterinary Release Form (Exhibit C) which shall all become part of this Contract. Any reference to pets in this Contract shall refer to those specified on the Pet Information Sheet.

Description of Services: Doggie Daycare

Beginning on _____, the Pet Sitter will provide the following services (collectively, "Services"):

Doggie daycare is provided in the Pet Sitter's home during daytime hours and includes supervised play, rest periods, potty breaks, and individualized attention. Daycare is ideal for socialization and structured care while the Owner is away during the day.

Half-day and full-day rates are agreed upon in advance. \$_____ per visit.

Payment for Services

The Pet Sitter shall be paid the amount of \$_____ and no deductions shall be made for late departure or early return of the Owner.

Additional fees may include the purchase of necessary items for the care of the pet, including but not limited to pet food, litter or cleaning supplies, transportation, unexpected visits and

emergency expenses for health care. The Pet Sitter shall retain and submit receipts as proof of additional expenses.

The amount of \$_____ shall be payable in advance and payment of all additional fees or expenses effected within 30 days of receipt of the billing for the outstanding balance.

Term

This Contract shall terminate automatically on _____.

Termination

Either party may end this Contract prior to the Termination Date, with or without cause, upon _____ days' written notice to the other party ("Early Termination"). Upon Early Termination, the Pet Sitter shall receive a pro-rated payment for the Services rendered prior to the Early Termination Date. An email notice to the other party will suffice.

Emergencies

In the event of an emergency, the Pet Sitter shall contact the Owner at the numbers provided to confirm the Owner's choice of action. If the Owner cannot be reached in a timely manner, the Pet Sitter is authorized to:

- (a) Transport the pet(s) to the listed veterinarian on the attached Veterinary Release Form;
- (b) Request on-site treatment from a veterinarian; or
- (c) Transport the pet(s) to an emergency clinic if the previous two options are not feasible.

Applicable Law

This Contract shall be governed by the laws of Sioux Falls, and South Dakota and include 6.2% sales tax added to the pricing listed above.
